Eligibility & Exclusions

13. Entry & Competition Procedure

14. The Promotion will be conducted during the Promotion Period.
15. Contestants may enter this Promotion in accordance with Competition Procedure.
16. Games of Chance - Prize Draw: If a Prize is awarded via a prize draw; or a random element being a game of chance; the draw will take place in accordance with the Draw Details. The Promoter will conduct random computerised draw of all eligible entrants to determine prize winners. All draws will be conducted in the presence of representatives of the Promoter, together with a witness of the Promoter draws in

accordance with state required scrutineering and supervision requirements (as relevant). For any Major Prize Draw with an Event, Finalists (or the Finalist's appointed proxy) must be in attendance at the Major Prize Event and witness the draw to determine a Winner. Attendance is mandatory.

25. 29. Release & Indemnity

30. 31. 32. 35.
